	<b>G0403</b>	Electrocardiogram, routine ECG with 12 leads; performed as a screening for the IPPE with interpretation and report		
	<b>G0404</b>	Electrocardiogram, routine ECG with 12 leads; tracing only, without interpretation and report, performed as a screening for the IPPE		
	<b>G0405</b>	Electrocardiogram, routine ECG with 12 leads; interpretation and report only, as a screening for the IPPE

<b>ACP - Advance Care Planning</b> (optional element of AWV)	<b>99497</b>	Advance care planning including the explanation and discussion of advance directives such as standard forms (with completion of such forms, when performed), by the physician or other qualified health care professional; first 30 minutes, face-to-face with the patient, family member(s), and/or surrogate	Coinsurance/deductable waived for ACP when provided on the same day by the same provider at the covered AWV; billed with <b>modifier 33</b> (preventive service) and billed on the same claim as the AWV	Once annually when billed with AWV (coinsurance or deductible waived)
	<b>99498</b>	As above but <b>each additional 30 minutes</b> (list separately in addition to code for primary procedure)	As above	As above
